# A. PRIZE DRAW TERMS & CONDITIONS

17<sup>th</sup> November 2025

#### The Promoter

1. The Promoter is Iress FS Limited (Company No. 02958430) of Honeybourne Place, Jessop Avenue, Cheltenham, England, England, GL50 3SH.

# **Eligibility Requirements**

- 2. The prize draw ("Prize Draw") is open to Individuals and companies currently sourcing protection products via an Iress Portal in the United Kingdom who satisfy all of the requirements laid out in this clause 2 ("Eligibility Requirements"):
  - a) You must be an Iress license holder for any of the following portals. The Exchange, Xplan Mortgage, O&M Profiler or Trigold.

## **Prize Draw Entry**

- 3. Subject to satisfaction of the Eligibility Requirements in clause 2 above, the Prize Draw is free to enter and no purchase is necessary.

#### **Opening and Closing Dates**

12. The opening date for entries is **9am on Monday 17**<sup>th</sup> **of November 2025**. The closing date for entries is **Friday 19**<sup>th</sup> **December at 4pm** ("Closing Date"). All entries received after the Closing Date will be automatically disallowed from the Prize Draw.

### **Winner**

- 14. The winner will be notified by Email using details provided on the Entry Form before 12<sup>th</sup> January 2026. - 24. The winner consents to sharing their first name and company name to anyone who emails advertising@iress.com within 30 days of the Closing Date. If you object to any or all of your first name and company name and winning entry being published or made available, please contact the Promoter at advertising@iress.com. In such circumstances, the Promoter must still provide the information and winning entry to the Advertising Standards Authority upon request.

#### **Data Protection**

25. See also clauses 23 and 24 in relation to the announcement of winners.

### **Limitation of Liability**

26. Insofar as permitted by law, the Promoter, its agents or distributors will not in any circumstances be responsible or liable to compensate the winner or accept any liability for any loss, damage, personal injury or death occurring as a result of taking up the Prize except where it is caused by the negligence of the Promoter, its agents or distributors or that of their employees. Your statutory rights are not affected.

# **Ownership of Prize Draw Entries and Intellectual Property Rights**

- 27. All entries and accompanying material submitted to the Promoter will become the property of the Promoter upon receipt and will not be returned
- 28. By submitting your entry and any accompanying material, you agree to:

in and to your entry and otherwise arising in connection with your entry to which you may now or at any time in the future be entitled under the Copyright, Designs and Patents Act 1988 as amended from time to time and under all similar legislation from time to time in force anywhere in the world.

### General

- 29. If there is any reason to believe that there has been a breach of these terms and conditions then the Promoter reserves the right to exclude you from participating in the Prize Draw.
- 30. The Promoter reserves the right to hold void, suspend, cancel or amend the Prize Draw where it becomes necessary to do so.
- 31. These terms and conditions shall be governed by the laws of England and Wales, and the parties submit to the exclusive jurisdiction of the courts of England and Wales.
